## ClearPath Action Fund Files \$555k more for Pro-Murkowski Ads

Additional advertising spend for 11 clean energy champions highlighting their records and voter mobilization

ClearPath Action Fund filed a \$555,000 independent expenditure for advertising in Alaska to close the campaign for Sen. Lisa Murkowski's (R-AK) reelection. This will bring ClearPath Action Fund's total spend to \$1 million in Alaska highlighting Murkowski's clean energy achievements. The current campaign, "Protecting Alaska's Interests," will air on network and cable TV as well as digital platforms across the state until election day.

"ClearPath Action Fund got <u>out of the gate</u> early for Senator Murkowski, and we're closing strong because her resume of results for clean energy innovation is impeccable. Lisa has been the driving force behind the biggest bipartisan energy policy wins over the past decade," **said Jay Faison, founder of ClearPath, Inc.** 

The ClearPath Action Fund 2022 clean energy champions were selected based on their proven record on key clean energy innovation legislation, tax incentives for breakthrough clean energy technology, and research and development support.

"These champions know that heavy mandates, more taxation, and the Green New Deal have little or no impact on carbon dioxide emissions reductions around the globe. They are putting America first with clean energy plans that invest in innovation, build clean energy faster by modernizing permitting, unlock American resource independence, and bring manufacturing back to the US where environmental standards are higher than places like China," said Faison.
